This system enables you to make bookings 24/7. The bookings page is linked from CBD Health Plus website and it's the only page shared with the public. New bookings are synchronised with the Cliniko appointment calendar.
- •You will receive a confirmation email upon making an online booking and then email or SMS reminder (10am) one day prior to your appointment.

- •Patients who book an appointment on the day by telephone will receive a text message or an email to their mobile phone number with all the information they will need in preparation to arriving for their treatment. Online bookings are for 1 PERSON ONLY.
- •If you need to reschedule your appointment or cancel it altogether please contact us on +61 (08) 9211 1103. A fee may be charged if a client does not show up for an appointment or if insufficient notice is given. You may also cancel your appointment/ reschedule through the initial appointment reminder message. You will be able to click on a link to cancel your appointment.
